Promotional Terms and Conditions

- 1. By entering the Promotion, Participants agree to be bound by these Promotional Terms and Conditions.
- 2. The promoter is Aon Risk Services Australia Limited ABN 17 000 434 720 AFSL no. 241141 (Aon) of Level 33, 201 Kent Street, Sydney NSW 2000 Telephone (02) 9253 7000 (Promoter).
- 3. The 'DuluxTRADE points with every new Aon business insurance policy' promotion (Promotion) commences at 8:00am AEST on Monday 1st September 2025 and ends on 31st December 2027 (Promotion Period).
- 4. Entry into the Promotion is only open to Australian residents who at the date of entry are 18 years of age or older and are a current Dulux Accredited Painter or DuluxTRADE Rewards member (Eligible Person). In the avoidance of doubt, employees of the Promoter, immediate family members of such employees, related companies of the Promoter and agencies associated with this Promotion, are ineligible to receive the Incentive of the Promotion.
- 5. Eligible Persons who have purchased a new Trades Business Insurance policy (Policy) through the Promoter during the Promotion Period and have met the Qualifying Criteria (Participants) will receive the Incentive.
- 6. To qualify for the Incentive (Qualifying Criteria), Participants must have taken out and paid for a new Policy through Aon and paid for their policy in full or in instalments via a premium funding arrangement with the Provider during the Promotion Period, and have their Policy remain in place for a minimum of 30 calendar days (Waiting Period).
- 7. The Incentive awarded is 15,000 DuluxTRADE points for Dulux Accredited Painters and 10,000 DuluxTRADE points for DuluxTRADE Rewards members who are not a Dulux Accredited Painter.
- 8. The Incentive will be uploaded to your DuluxTRADE Rewards account within 90 business days after the Waiting Period is complete.
- 9. The Incentive value is equivalent to \$75 for 15,0000 DuluxTRADE points and \$50 for 10,000 DuluxTRADE points.
